SPECIAL CALL FOR APPLICATION FOR INTERNATIONAL STUDENTS ACADEMIC YEAR 2022/2023

João Paulo Pereira de Freitas Coroado, President of IPT, hereby makes it known that, under the terms of IPT's International Student Regulations, a special calls for application from international students (CEEI) is now open for admission to the undergraduate programmes offered at Instituto Politécnico de Tomar (IPT) in the academic year 2022/2023.

1. Scope and Admission Requirements

1.1 Scope of Application:

Concept of International Student (article 3 of DL 36/2014 as amended by DL 62/2018)

International Student is a student who does not have Portuguese nationality, except in the case of:

- a) Nationals of a Member State of the European Union;
- b) Family members of Portuguese nationals or of nationals of a Member State of the European Union, whatever their nationality;
- c) People who, not being nationals of a member state of the European Union and not covered by the previous paragraph, have been legally residing in Portugal for more than two years without interruption on 1 January of the year they are applying for, as well as their children who are legally residing with them (excluding the period of a residence permit for study);
- d) People who, on January 1st of the year they are applying for, benefit from the equal status of rights and duties granted under an international treaty between the Portuguese State and the State of which they are nationals;
- e) People who apply for entry into higher education through the special application calls regulated by Decree-Law 393-A/99 of 2 October as amended by Decree-Law 272/2009, of 1 October
- f) Foreign students who are attending a Portuguese higher education institution as part of an international mobility programme for part of a course of studies of a foreign higher education institution with which the Portuguese institution has established an exchange agreement for that purpose.
- g) Entry to IPT's degree programmes by applicants covered by the preceding paragraphs (a) to (d) can only take place under the same terms as students with Portuguese nationality.



1.2 Admission requirements:

The following international students are eligible to apply for the undergraduate programmes leading to an undergraduate degree (*licenciado*) offered by IPT schools.

- a) Holders of a qualification giving access to higher education, ie any diploma or certificate issued by a competent authority attesting to successful completion of an education programme and conferring on them the right to apply and be able to enter higher education in the country in which it was awarded;
- b) Holders of a Portuguese secondary education diploma or legally equivalent qualification.

1.3 Entry terms and conditions:

In order to be admitted to a course of study at IPT Schools, international students must meet all of the following conditions:

- a) Have an academic qualification in the fields of knowledge required for the course of study for which they are applying as laid down in Annex I or II and in Article 5 of IPT's regulations concerning international student admission (Regulamento de Aplicação do Regime Legal do Estudante Internacional) available from the IPT's website at http://portal2.ipt.pt/pt/,candidaturas/Estudante Internacional/
- b) Have a level of proficiency of the Portuguese language required to attend this course of studies or undertake to reach it at the IPT before starting attendance as defined in Article
 6 of IPT's regulations concerning international student admission (Regulamento de Aplicação do Regime Legal do Estudante Internacional).
- c) The fulfilment of the conditions laid down in the previous paragraphs will be verified as provided for in article 5 et seq. of IPT's regulations concerning international student admission (Regulamento de Aplicação do Regime Legal do Estudante Internacional).

2. Timelines

The timelines for the actions to be undertaken as part of this call are set out in Annex I to this Notice.

3. Degree programmes/student places for which applications are accepted

3.1. Applications to the special calls for international students are accepted for the programmes of study leading to undergraduate awards (*licenciado*) offered by IPT Schools, with student places set for each Institution/Programme pair in Annex II to this Notice.



3.2. Student places shall be allocated by group according to the origin of the applicants (also set out in Annex II to this Notice). The remaining places, in any or all of these groups, are re-allocated equally to the applicant students from groups with all places filled.

to the unplaced students from groups with all places filled.

3.3. A third and a fourth round of applications may be offered within deadlines to be set later for

each Institution/Programme where there are available places from the previous round(s).

4. Instructions on the preparation of applications

4.1. Applications are submitted exclusively in electronic format by accessing the IPT website at

http://portal2.ipt.pt/pt/candidaturas/Estudante_Internacional/ within the deadlines specified in

Annex I to this Notice.

4.2 The application must be accompanied by the following documents:

a) Application form filled in online;

b) Upload of the following documents to the online system:

i. Copy of Identification Document, preferably passport;

ii. Copy of document(s) proving personal details and academic qualifications in

accordance with Annex III to this Notice;

iii. Proof of payment of the application fee of EUR 50 (fifty Euros) made by deposit in

an account or bank transfer to the following IPT bank account:

4.4 The application fee will not be refunded under any circumstances.

4.5 Any errors or omissions in completing the online application form or in the documents

accompanying the application are the sole responsibility of the applicant.

5. Minimum grade required for the academic qualifications relevant to this application

A minimum ovacific of 9.5 out of 20 as specific academic qualification is required for admission purposes.

6. Sorting Criteria

- **6.1.** Applicants will be sorted in descending order of the final score of the specific academic qualification according to IPT's regulations concerning international student admission (Regulamento de Aplicação do Regime Legal do Estudante Internacional).
- **6.2**. If the number of applicants for a particular School/Programme is less than the number of places available, all applicants who meet the application requirements will be placed in alphabetical order.

7. Publication of Results

The results of the calls will be made public through a Notice which will be made available on the IPT website at http://portal2.ipt.pt/pt/candidaturas/Estudante_Internacional/ within the deadlines set out in Annex I to this Notice.

8. Information on appeal procedures

- **8.1.** Applicants may lodge a duly substantiated appeal against the results of the admissions procedure.
- **8.2.** The appeal shall be made by request addressed to the President of the IPT within the time limits set out in Annex I to this Notice. Unsubstantiated appeals whose requests are unintelligible as well as those that have not been lodged by the end of the deadline shall be automatically rejected.

9. Rejection of Applicants

Applicants who do not submit the required documents, make false declarations and/or fail to meet the conditions laid down for application will be excluded from the application process at any time.

11. Registration | Enrolment, Administration Fees and Charges and Tuition Fees

- **11.1.** Registrations and enrolments of placed applicants are made within the time limits set out in Annex I to this Notice in the academic services of Tomar (ESTT and ESGT) and Abrantes (ESTA).
- **11.2.** Upon registration/enrolment, students are required to pay school insurance to the amount of EUR 2.00 per year and the full amount of the annual tuition fee.
- 11.3. The tuition fees for the school year 2022/2023 are as shown in Annex IV.
